Karla also described the living conditions on the Pine Ridge Reservation in South Dakota where she has worked. A brief business meeting followed Karla's program with President Maryjo Flamm-Miller presiding.

### Old Business

The Altrusa Bazaar netted us only \$35. Seventy-five dollars was made from the sale of our crocheted necklaces, but the booth rental was \$40.00. Appreciation was given to those who worked at the booth. We will be closing out the Necklace Fundraiser project by selling the remaining jewelry at a discounted price of 50%. Necklaces will be sold to members for \$5 each and at the Pump House Holiday Bazaar for \$7 (PH collects 30%).

### Treasurer's Report

The Book Sale netted \$6,007.00. We have \$2,436.89 as a balance in our Branch checking account.

### New Business

Our Christmas program will be at the Pump House on Dec. 20 2012 at 6:00. Jean Ziogas reminded us to bring 2 dishes of finger food to share (one savory, one sweet), plus canned goods to donate to the Good Samaritan Food Pantry.

Maryjo reminded us that the Addendum to the Yearbook is available in the November *Cap & Gown*.

Our Branch Liability Insurance has been renewed for 2013. This protects us as we meet and volunteer at events, as well as any guests who attend our activities.

**Save the Date:** We will be participating in the **March 20** Women's History Month event at OU-C's Quinn Library. ## **HAVE YOU READ THE NEWEST AAUW REPORTS?**

**Graduating to a Pay Gap: The Earnings of Women and Men One Year after College Graduation** explores the earnings difference between female and male college graduates who are working full time one year after graduation. The report, which uses the latest nationally representative data, compares apples to apples by looking at the pay gap after controlling for various factors known to affect earnings, such as occupation, college major, and hours worked.
